Contributions from Corporations, LLCs and State PACs are accepted and will be deposited in the Conservative Party's accounts subject to the provisions of the New York State Election Law. PACs are limited to \$117,300 in aggregate political contributions. Corporations and LLCs are limited to an aggregate of \$5,000 annually. Any amount exceeding PAC limits and all LLC and Corporate contributions will be deposited into Party housekeeping accounts which may receive unlimited contributions. All LLC and Corporate contributions are solicited solely for housekeeping purposes.
